

**RESOLUTION OF THE BOARD OF DIRECTORS OF
CENTRAL PLATTE VALLEY METROPOLITAN DISTRICT
AMENDING THE PUBLIC RECORDS POLICY**

WHEREAS, the District adopted a public records policy (“Policy”) by resolution in December 2014; and

WHEREAS, since the adoption of the Policy, the state legislature has amended certain provisions of the Colorado Open Records Act (“CORA”) upon which the Policy is based;

WHEREAS, the Board wishes to amend the Policy to be consistent with CORA.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF CENTRAL PLATTE VALLEY METROPOLITAN DISTRICT THAT:

Section 1. All capitalized terms herein shall have the same meaning as in the Policy.

Section 2. Pursuant to Section 24-72-205(6) and the Policy, the maximum hourly fee for the research and retrieval of public documents in response to a request will increase to \$41.37 as of November 1, 2024.

Section 3. Any increases or decreases in the maximum hourly fee for the research and retrieval of public documents and any increases or decreases in the cost per page for copies will hereafter automatically adjust to the rate adopted by the state legislature under CORA as of the effective date of the increase or decrease under CORA.

Section 4. Except as specifically amended herein, the Policy remains in full force and effect.

Electronic Record and Signature Disclosure

ELECTRONIC RECORD AND SIGNATURE DISCLOSURE

From time to time, CliftonLarsonAllen LLP (we, us or Company) may be required by law to provide to you certain written notices or disclosures.
